CHARLES K WEST HAD ASKED TO BE ON THE AGENDA TO PRESENT AS A MEMBER OF THE ZONING BOARD OF APPEALS. COMMITTEE REPORTS:

BOYLAN INFORMED COUNIL THAT THE ZONING AND PLANNING COMMITTEE WAS SCHEDULED TO MEET ON MAY 2ND BUT IT WAS CANCELED DUE TO LACK OF ATTENDENCE. ONE BIG CONCERN OF THE COMMITTEE THAT REMAINS IS OHIO ISSUE II THAT PASSED IN LAST FALLS GENERAL ELECTION. BOYLAN PRESENTED A POSSIBLE ORDINANCE FOR COUCIL TO CONSIDER. DISCUSSION TOOK PLACE ON ISSUE II WITH INPUT FROM SOLICITOR STANLEY. FOLLOWING DISCUSSION NO ACTION WAS TAKEN. THE COMMITTEE IS ALSO DISCUSSING SIDEWALK ISSUES IN THE NEW ADDITIONS FOR PROPERTY THAT MAY NOT YET BE PURCHASED TO BUILT ON AND SIDEWALKS ENDING BETWEEN PROPERTIES.

SMITH INFORMED COUNCIL THAT THE PERSONNEL COMMITTEE HAD MET ON APRIL 23RD AND PRESENTED COUNCIL WITH THE MINUTES FROM THE MEETING.

OLD BUSINESS:

STEINER ASKED ABOUT THE PRESSURE WASHING OF THE LIBRARY BY VILLAGE EMPLOYEES. DAVIS INFORMED STEINER THAT HE HAD GIVEN HIS ANSWER ON THE WORK IN QUESTION AT THE PRIOR MEETING AND WOULD NOT REVISIT THE ISSUE. HORNISH INFORMED COUNCIL THAT HE HAD A VILLAGE RESIDENT IN HIS OFFICE WHO ASKED TO VOLUNTEER TO DO THE POWERWASHING WORK AT THE LIBRARY. HORNISH DIRECTED THE INDIVIDUAL TO CONTACT THE LIBRARY PERSONNEL TO SEEK PERMISSION TO PERFORM THE WORK.

ADMIN DAVIS UPDATED COUNCIL ON THE STATUS OF PROJECTS THAT HE IS WORKING ON FOR THE VILLAGE. ENGINEERING FOR BOTH THE CANAL/WENTWORTH PROJECT AND THE WATERPLANT DESIGN IS APPROXIMATELY 35% COMPLETE. STEINER ASKED ABOUT THE GUARDRAIL ON CANAL BEING DAMAGED. DAVIS INFORMED COUNCIL THAT NEW "U SHAPED" PIPES SIMILAR TO WHAT IS ON MAIN STREET HAVE BEEN ORDERED TO REPLACE THE AREA OF THE GUARDRAIL THAT WAS DAMAGED.

COUNCIL RETURNED FROM EXECUTIVE SESSION AT 6:45 WITH NO ACTION TAKEN. SOLICITOR STANELY ASKED STEINER TO EXIT COUNCIL CHAMBERS WHILE ACTION WAS TAKING PLACE IN REGARD TO 103 WILCOX
