

Preliminary Consent Legislation

The following is an _____ ordinance _____ enacted by the _____ Village _____ of _____ Antwerp _____, _____ Paulding _____ County, Ohio, hereinafter referred to as the Local Public Agency (LPA), in the matter of the stated described project.

SECTION I - Project Description

WHEREAS, the LPA has identified the need for the described project:

This project proposes resurfacing on the following State Route within the village of Antwerp:

- On SR 49 from the north corp. limit of the village of Payne to Canal Street in the village of Antwerp. Resuming at the north corporation limit of Antwerp and continuing to the south corp. limit of Hicksville.

WHEREAS, a portion of the described project is within the village corporation limits.

NOW THEREFORE, be it ordained by the Village of Antwerp of Paulding County, Ohio.

SECTION II - Consent Statement

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

SECTION III - Cooperation Statement

The LPA shall cooperate with the Director of Transportation in the above described project as follows:

ODOT and FHWA shall assume and bear 100% of the necessary costs of the state's highway improvement project. In the event that the village requests certain features or appurtenances to be included within the state's highway improvement project's design and construction, and which features and appurtenances are determined by the state to be not necessary for the state's project, the village shall contribute 100% of the cost of those items.
