

RESOLUTION NO. 2024-18

A RESOLUTION AUTHORIZING THE FISCAL OFFICER OF THE VILLAGE OF ANTWERP, OHIO TO AMEND APPROPRIATIONS AND DECLARING AN EMERGENCY

WHEREAS, the Fiscal Officer has determined that it is necessary to amend the following appropriations; and

WHEREAS, Council must approve the amending of appropriations pursuant to Ohio Revised Code Section 5705.40, and council finds it to be in the best interest of the Village that such adjustments in appropriations be amended, authorized and approved; and

WHEREAS, this is necessary for the preservation of the public health, safety and welfare of the residents of the Village and deemed to be an emergency.

NOW, THEREFORE, BE IT RESOLVED BY A MINIMUM OF A THREE-FOURTHS VOTE by the Council of the Village of Antwerp, Paulding County, Ohio:

Section 1. That the rules requiring three readings of any ordinance or resolution prior to its passage by a minimum of the majority of the council are hereby suspended pursuant to Ohio Revised Code Section 705.15.

Section 2: The Fiscal Officer is hereby authorized to amend the following appropriations:



Section 4: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety, and welfare of the Village of Antwerp, Ohio and for the further reason that the appropriations identified herein need to be amended in 2024 to provide for the continuing operation of Village services, and provided it receives the affirmative vote of at least three-fourths of the members of this Council, the Resolution shall take effect and be in force immediately upon its adoption by this Council or otherwise it shall take effect and be in force after the earliest period allow by law.
