DAVIS HAS ALSO SECURED A GRANT WITH ODNR FOR \$7500 WHICH WILL BE USED FOR A SIDEWALK IN THE PARK TO CONNECT THE SPLASH PAD TO THE NEW BRIDGE.

CHIEF CLEMENS ASKED COUNCIL TO ENTERTAIN A MOTION TO APPROVE ALEC INGRAMS APPOINTMENT AS A NEW POLICE OFFICER FOR THE VILLAGE.

STEINER ASKED ABOUT GETTING A PRICE TO ARCHIVE AND DIGITIZE THE OLD VILLAGE ORDINANCES ONTO THE VILLAGE WEBSITE. DAVIS WILL SEE IF HE CAN GET AN ESTIMATE FOR THE COST TO PERFORM THIS WORK.
