

The Council of the Village of Antwerp passed **Resolution 2025-08** on May 14th, 2025, entitled “A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE POLICE CHIEF OF THE VILLAGE OF ANTWERP OHIO REGARDING PAYMENT FOR HIS ACCRUED BUT UNUSED SICK LEAVE TIME AND DECLARING THE SAME AN EMERGENCY.” This resolution authorizes the Mayor and Police Chief to enter into an agreement regarding his unused sick leave time in relation to the Village of Antwerp Employee Handbook and his entry into “retired” status with OPF.

The Council of the Village of Antwerp passed **Resolution 2025-09** on May 14th, 2025, entitled, “A RESOLUTION OF NECESSITY TO LEVY A REPLACEMENT WITH AN INCREASE OF AN EXISTING TAX IN EXCESS OF THE TEN-MILL LIMITATION FOR THE PURPOSE OF MAINTAINING AND OPERATING A CEMETERY.” This resolution is declaring the necessity of levying a replacement levy for the purpose of maintaining and operating a cemetery to be placed on the ballot for the November election.

The Council of the Village of Antwerp passed **Resolution 2025-10** on May 14th, 2025, entitled, “A RESOLUTION AUTHORIZING THE VILLAGE TO ENTER INTO A NEW ANNEXATION AGREEMENT WITH CARRYALL TOWNSHIP, PAULDING COUNTY, OHIO REGARDING CERTAIN REAL PROPERTY LOCATED ADJACENT TO THE VILLAGE AND DECLARING THE SAME AN EMERGENCY.” This resolution creates a new annexation agreement with Carryall Township to correct errors that were contained in a prior agreement established under Resolution 2024-24 that was completed on December 11, 2024. Resolution 2024-24 is now null and void.

The Council of the Village of Antwerp passed **Ordinance 2025-07** on May 14th, 2025, entitled, “AN ORDINANCE ACCEPTING THE CONVEYANCE OF PAULDING COUNTY AUDITOR’S PARCEL NUMBER 12-07S-010-00 FROM THE COMMUNITY IMPROVEMENT CORPORATION OF ANTWERP, OHIO, DEDICATING THE SAME AS MEYER AVENUE IN THE VILLAGE OF ANTWERP, OHIO AND DECLARING THE SAME AN EMERGENCY.” This ordinance shows council’s wish to accept the donation of the referenced parcel from the CIC of Antwerp and dedicating the same for use as a public road entrance to a new residential subdivision in the Village as well as accepts the monetary donation from a private individual in exchange for naming the new public road “Meyer Avenue.”
