

ORDINANCE NO. 2025-07

AN ORDINANCE ACCEPTING THE CONVEYANCE OF PAULDING COUNTY AUDITOR'S PARCEL NUMBER 12-07S-010-00 FROM THE COMMUNITY IMPROVEMENT CORPORATION OF ANTWERP, OHIO, DEDICATING THE SAME AS MEYER AVENUE IN THE VILLAGE OF ANTWERP, OHIO AND DECLARING THE SAME AN EMERGENCY

WHEREAS, the Community Improvement Corporation of Antwerp, Ohio has proposed to donate Paulding County Auditor's Parcel Number 12-07S-010-00 to the Village of Antwerp, Ohio for use as an entrance road to a new residential development in the Village; and

WHEREAS, a private individual has proposed to donate the sum of Twenty Thousand and 00/100 dollars (\$20,000) in order for the entrance road to be named 'Meyer Avenue'; and

WHEREAS, the Village of Antwerp, Ohio Zoning and Planning Commission has considered and approved of the plan for the Village to accept this parcel and create upon it a public road called 'Meyer Avenue'; and

WHEREAS, the Council now wishes to accept the donation of Paulding County Auditor's Parcel Number 12-07S-010-00 from the Community Improvement Corporation of Antwerp, Ohio, dedicating the same for use as a public road entrance to a new residential subdivision in the Village; and

WHEREAS, the Council now wishes to also accept the Twenty Thousand and 00/100 dollar (\$20,000.00) donation from a private individual in exchange for naming the new public road, to be located on Paulding County Auditor's Parcel No. 12-07S-010-00, as 'Meyer Avenue'; and

WHEREAS, this Ordinance taking effect immediately is necessary to ensure timely progression of the newly dedicated street and the new residential subdivision, as well as the immediate preservation of the public peace, health, safety and general welfare of the Village.

NOW, THEREFORE, BE IT ORDAINED BY A MINIMUM OF A THREE-FOURTHS VOTE by the Council of the Village of Antwerp, Paulding County, Ohio:

Section 1. That the rules requiring three readings of any ordinance or resolution prior to its passage by a minimum of the majority of the council are hereby suspended pursuant to Ohio Revised Code Section 705.15.

Section 2. That the Council hereby accepts the donation of Paulding County Auditor's Parcel Number 12-07S-010-00 to the Village of Antwerp, Ohio by the Community Improvement Corporation of Antwerp, Ohio.

Section 3. That the Council hereby accepts the donation of Twenty Thousand and 00/100 dollars (\$20,000) to the Village of Antwerp, Ohio by a private individual in exchange for naming the public road to be placed on Paulding County Auditor's Parcel Number 12-07S-010-00 'Meyer Avenue'.

Section 4. That the Council further dedicates Paulding County Auditor's Parcel Number 12-07S-010-00 for use as a public road in the Village, to be known henceforth as 'Meyer Avenue'.

Section 5. That the Village Mayor and Administrator are hereby authorized to execute any documents necessary to accomplish the acceptance, dedication and naming of Paulding County Auditor's Parcel Number 12-07S-010-00 as a public road in the Village to be called 'Meyer Avenue'.

Section 6. That the Village administrator is hereby directed to forward a certified copy of this ordinance to the Paulding County Engineer for entry in the Engineer's record of streets in the County.

Section 7. It is found and determined that all formal actions of the Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements.

Section 8. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety, and welfare of the Village of Antwerp, Ohio, more specifically, Council wishes to facilitate the timely progression of the new street and subdivision, and provided it receives the affirmative vote of at least three-fourths of the members of this Council, the Ordinance shall take effect and be in force immediately upon its adoption by this Council or otherwise it shall take effect and be in force after the earliest period allow by law.
