

ORDINANCE NO. 2025-09

AN ORDINANCE RENAMING A PORTION OF STONE STREET IN THE VILLAGE OF ANTWERP, OHIO, SPANNING FROM THE INTERSECTION OF STONE STREET AND SOUTH MAIN STREET TO THE INTERSECTION OF STONE STREET AND ERIE STREET, TO BOURBON STREET

WHEREAS, the Council of the Village of Antwerp, Ohio has received a petition from Jeff Cook and Todd Cook, being the owners of all real estate in the Village of Antwerp, Ohio fronting that portion of Stone Street spanning from its intersection with South Main Street to its intersection with Erie Street, to rename such portion of Stone Street to Bourbon Street; and

WHEREAS, the Council has also received a recommendation from the Village Zoning and Planning Commission, pursuant to the Village Zoning and Planning Commission's meeting held April 3, 2025, that the above-described renaming of a portion of Stone Street in the Village of Antwerp, Ohio to Bourbon Street be approved; and

WHEREAS, in accordance with Ohio Revised Code Section 723.04, the Council now wishes to pass this ordinance in order to effectuate the above-described street name change.

NOW, THEREFORE, BE IT ORDAINED BY A MINIMUM OF A MAJORITY VOTE by the Council of the Village of Antwerp, Paulding County, Ohio:

Section 1. That the portion of Stone Street in the Village of Antwerp, Ohio spanning from its intersection with South Main Street to its intersection with Erie Street be renamed to Bourbon Street.

Section 2. That the Village Administrator is hereby authorized and directed to share a certified copy of this ordinance with the Paulding County Engineer in order to allow this change to be reflected in the County GIS and EMA records.

Section 3. That the Village Administrator is hereby authorized and directed to update the Village zoning map to reflect this change.

Section 4. That the Village Administrator is hereby authorized and directed to cause the street signs for this portion of what is now formerly Stone Street to be updated to reflect that this portion is being renamed to Bourbon Street, with the costs associated with said signage update to be assessed to Jeff Cook and Todd Cook.

Section 5. It is found and determined that all formal actions of the Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements.


Section 6. That this ordinance shall take effect at the earliest time allowable under the laws of the State of Ohio.
