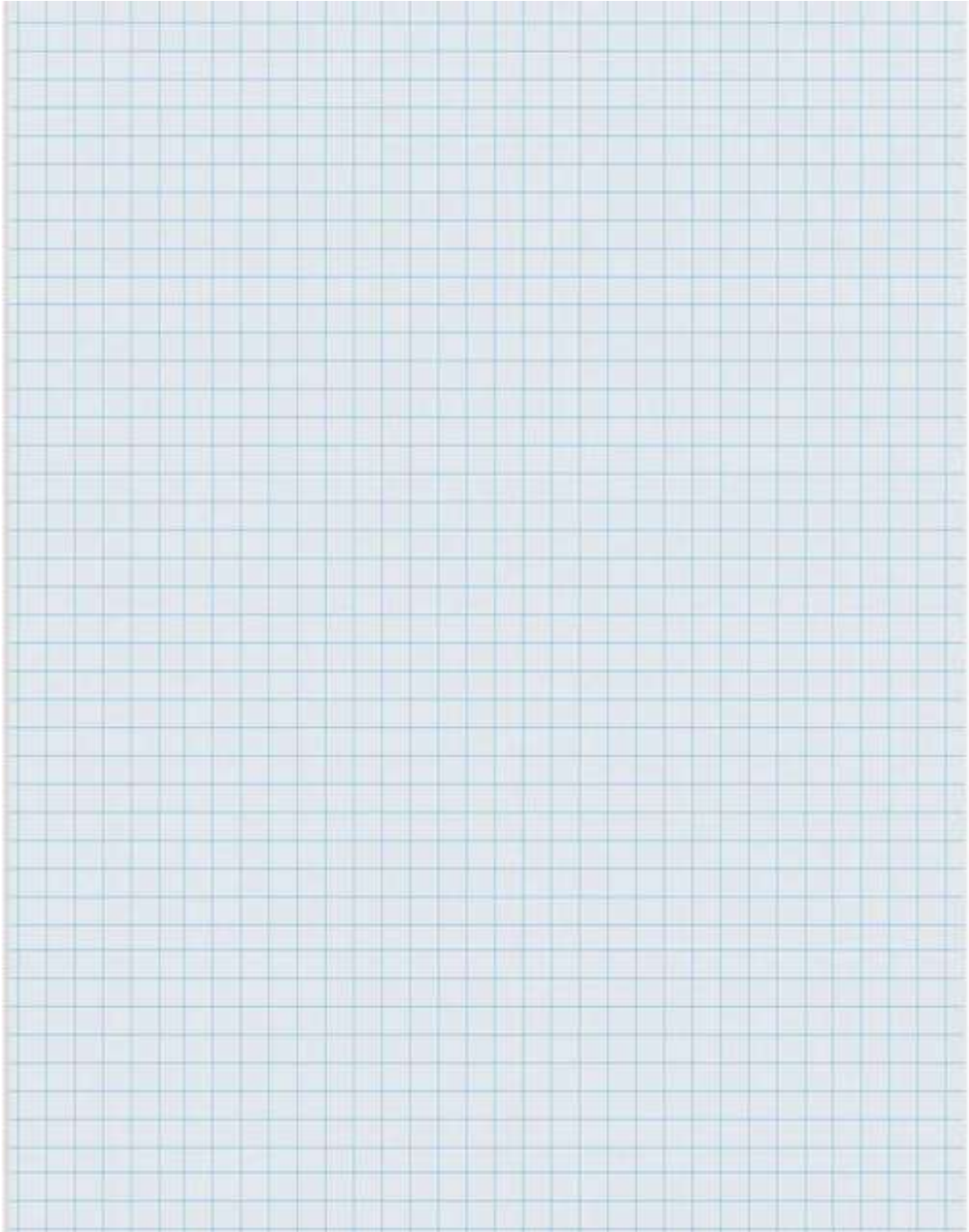

Additionally, it is understood that if the project results in the creation of more than 4 off-street parking spaces a site plan review is required by the Planning & Zoning Commission furthermore, State building permits are required for business projects.
