

**Regular Meeting
Council of the Village of Antwerp
July 9, 2025**

Mayor Jan Reeb called the regular meeting of the Village of Antwerp Council to order at 5:30 P.M.
Council members present: Dean Rister, Bill Boylan, Bryce Steiner, Jason Franks, John DeVore III and Bryan Smith

Also attending: Administrator Brian Davis, Fiscal Officer Kevin Hornish, Police Chief George Clemens and Solicitor Brandon Grigsby.

Council reviewed the June regular meeting minutes, Hornish noted a couple typos and spelling errors that had been corrected:

- Motion made by Stienner, seconded by Rister, to approve the minutes as corrected. 6 Yeas, 0 Nays. Motion carried and approved.

Council reviewed the June finance statements, bank reconciliation and R.I.T.A. report.

- Motion made by Franks, seconded by DeVore, to accept the June Financial Statements and Bank Reconciliation statement as presented. 6 Yeas, 0 Nays. Motion carried and approved.

Bill Boylan updated council on the Planning & Zoning Public Hearing

FISCAL OFFICER REPORT

3rd READING OF ORDINANCE 2025-09: An ordinance renaming a portion of Stone Street in the Village of Antwerp, Ohio, spanning from the intersection of Stone Street and South Main Street to the intersection of Stone Street and Erie Street, to Bourbon Street.

- Motion made by Boylan, seconded by Smith, to adopt Ordinance 2025-09. 6 Yeas, 0 Nays. Motion carried and approved.

2nd READING OF ORDINANCE 2025-08: An ordinance amending section 2 of ordinance no. 2000-19 establishing a schedule of fees, charges, and expenses, and a collection procedure for zoning

permits, amendments, appeals, variances, conditional use permits, and other matters relating to the administration and enforcement of zoning in the Village of Antwerp, Ohio, and regulating the fees paid to the zoning inspector for service.

1st READING OF RESOLUTION 2025-16: A resolution accepting the donation of fifty-four thousand five hundred and 00/100 (\$54,500.00) dollars from the Community Improvement Corporation of Antwerp, Ohio for use as partial funding for the purchase of Paulding County Auditor's parcel number 12-26S-011-00.

EMERGENCY READING OF ORDINANCE 2025-11: An ordinance amending section 311 of ordinance no. 1976-16, the zoning ordinance of Antwerp, Ohio, to add further business classifications to the permitted, conditional, accessory use table and declaring the same an emergency.

- Motion made by Boylan, seconded by Rister, to suspend the rules of three readings. 6 Years, 0 Nays. Motion carried and approved.
- Motion made by Boylan, seconded by DeVore, to adopt Ordinance 2025-11. 6 Years, 0 Nays. Motion carried and approved.

EMERGENCY READING OF ORDINANCE 2025-12: An ordinance accepting the final plat of the Maumee Landing subdivision -phase 15 (Lots 29 and 30) to the addition to the Village of Antwerp, Paulding County, Ohio pursuant to ordinance no. 94-17, and declaring the same an emergency.

- Motion made by Rister, seconded by Franks, to suspend the rules of three readings. 6 Years 0 Nays. Motion carried and approved.
- Motion made by Smith, seconded by Rister, to adopt Ordinance 2025-12. 6 Years, 0 Nays. Motion carried and approved.

OLD BUSINESS

Rister asked about the progress of Veteran Memorial Banners. Council discussed the project. Steiner is working with the school and hopes to have more information once school starts in August.

NEW BUSINESS

Davis updated council on projects in the village.

Steiner asked Davis to check on some potholes on Park Ave that need patched.

Franks asked Davis to check on low hanging tree branches on streets around town and the possibility of getting them trimmed.


Rister reminded council members and anyone else interested that there are 4 council seats available for election this fall, and petitions must be filed by August 6th.

MAYOR'S REPORT


