## **RESOLUTION NO. 2025-16**

A RESOLUTION ACCEPTING THE DONATION OF FIFTY-FOUR THOUSAND FIVE HUNDRED AND 00/100 (\$54,500.00) DOLLARS FROM THE COMMUNITY IMPROVEMENT CORPORATION OF ANTWERP, OHIO FOR USE AS PARTIAL FUNDING FOR THE PURCHASE OF PAULDING COUNTY AUDITOR'S PARCEL NUMBER 12-26S-011-00

WHEREAS, the Community Improvement Corporation of Antwerp, Ohio has proposed to donate Fifty-four Thousand Five Hundred and 00/100 (\$54,500.00) dollars to the Village of Antwerp, Ohio to help fund the purchase of Paulding County Auditor's Parcel Number 12-26S-011-00 for use in the SR 49/Canal Street widening project; and

WHEREAS, the Council of the Village desires to accept said donation and designate said Fifty-four Thousand Five Hundred and 00/100 (\$54,500.00) dollars as being only for use in purchasing Paulding County Auditor's Parcel Number 12-26S-011-00 in order to facilitate the SR49/Canal Street widening project.

NOW, THEREFORE, BE IT RESOLVED BY A MINIMUM OF A MAJORITY VOTE by the Council of the Village of Antwerp, Paulding County, Ohio:

<u>Section 1</u>. The Village Fiscal Officer is hereby authorized to take receipt of a Fifty-four Thousand Five Hundred and 00/100 (\$54,500.00) dollar donation from the Community Improvement Corporation of Antwerp, Ohio, for placement in the Village General Fund.

<u>Section 2</u>. The Village Fiscal Officer is hereby directed to accept said funds into the Village General Fund, with a designation that said funds are to be used as partial satisfaction of the purchase price of Paulding County Auditor's Parcel Number 12-26S-011-00, which property shall be used in the SR 49/Canal Street widening project.

Section 3. That it is hereby found and determined that all formal actions of the Council concerning or relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements.

**Section 4**. That this Resolution shall take effect and be in force after the earliest period allowed by law.
