## ORDINANCE NO. 2025-20

## AN ORDINANCE SETTING TEMPORARY APPROPRIATIONS FOR 2026 WHICH SHALL BE IN EFFECT UNTIL PERMANENT APPROPRIATIONS ARE SET OR APRIL 1, 2026, WHICHEVER SHALL OCCUR FIRST

WHEREAS, the Village of Antwerp has normal operating expenses which must be maintained and may not legally be paid without proper appropriations; and

WHEREAS, Ohio Revised Code § 5705.38 allows the Village to pass a temporary appropriations ordinance to ensure that Village accounts are funded until permanent appropriations can be passed or until April 1 of the relevant appropriations year, whichever shall occur first; and

WHEREAS, the Council finds it to be in the best interest of the Village to appropriate funds, according to ORC § 5705.38, as detailed in this Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY A MINIMUM OF A MAJORITY VOTE by the Council of the Village of Antwerp, Paulding County, Ohio as follows:

<u>Section 1</u>. That the following amounts be temporarily appropriated for fiscal year 2026 until permanent appropriations can be made or until April 1, 2026, whichever shall occur first:
